

Obtaining a Navy JAG Corps Interview

After submitting your completed application (all documentation except letters of recommendation) to the Navy JAG Corps Accessions Office via the application website, you will need to schedule an interview. This interview must be completed before the application deadline. Each applicant will be given only one interview, regardless of how many times an application is submitted.

Although letters of recommendation do not need to be submitted prior to scheduling an interview, letters of recommendation must be submitted via the application website or via e-mail to navyaccessions@navy.mil by the application deadline. Hardcopy letters of recommendation mailed to our office will no longer be accepted.

Two judge advocates will participate in each interview. At least one of the judge advocates will be a senior active-duty judge advocate (commander or above).

To schedule an appointment for an interview, all applicants must send an e-mail to the account listed below for your state. **There are two very important sections below for specific information about interviews in your geographic location: “Where to Send E-Mail Request Interview” and “Special Interview Information By Command/Region”.** Each applicant will be notified via e-mail of the date, time, and location for their interview.

Please e-mail your request for an interview well in advance of the application deadline. Due to the large number of applications we receive, we cannot guarantee that requests for interviews made near an application deadline will be accommodated.

You must bring a copy of your resume to the interview.
