

The Legal Assistance Department of Naval Legal Service Office Southwest is a free legal resource provided by the military to all eligible personnel. Legal Assistance can resolve most legal issues confronting the military, retiree, reservist, and family members in everyday life. However, sometimes due to the complexity of the case, or the experience of legal Assistance providers, the legal problem facing the client cannot be resolved or handled by the Legal Assistance Department. When legal problems cannot be resolved or handled by the department, the client will be referred to civilian legal resources for assistance.

If you have requested a referral to civilian legal resources, or have been referred to them by Legal Assistance personnel, you should consult with a private civilian attorney immediately in order to discuss the merits of your case and find out how much time you have to file a lawsuit. **Be aware that any inaction on your part in pursuing your case may affect your rights due to various statutes of limitations.**

When a client has been referred to civilian legal resources, it is done based solely upon the particular facts of your case or because you requested civilian counsel. Neither this office nor the individual attorneys have any present or expected direct or indirect personal interest in referring you to civilian counsel. Additionally, neither this office nor the individual attorneys will receive any payments or benefits of any kind from these civilian legal resources for this referral.

The following is a list of local attorneys, lawyer referral services, legal aid programs, and other assistance organizations to help you in obtaining civilian legal counsel. The listing of any attorney or other legal resource on this sheet does not constitute an endorsement of the attorney or other legal resources. All clients are encouraged to utilize other avenues of assistance, such as the Yellow Pages, in finding qualified civilian legal assistance with which the client feels comfortable and confident.
