The Legal Assistance Department of Region Legal Service Office Southwest (RLSO SW) is a free legal resource provided by the Navy to all eligible personnel. It can often resolve legal issues confronting military, retiree, reservist, and family members in everyday life. However, the complexity of the case, the experience of legal assistance providers, and the extent of the authorization of services we perform can sometimes preclude our ability to fully assist some clients. The best recourse often is to consult with civilian counsel off-base.

If your case warrants legal representation beyond the scope of what Region Legal Service Office provides, it is usually in your best interests to do so immediately. **Be aware that any inaction on your part in pursuing your case may affect your rights, as there are often time limitations for you to take certain legal actions.**

When a client is referred to civilian legal resources, it is based solely upon the particular facts of the case or on the client's request for civilian counsel. Neither this office nor the individual attorneys have any present or expected direct or indirect personal interest in referring you to civilian counsel or resources. Additionally, neither this office nor the individual RLSO attorneys will receive any payments or benefits of any kind from these civilian legal resources for any referral.

The following is a list of local attorneys, lawyer referral services, legal aid programs, and other legal assistance organizations which may be able to help you in obtaining civilian legal counsel. The listing of any attorney or other legal resource does not constitute an endorsement of the attorney or other legal resources. The attorneys on the list have requested to be on the Legal Assistance Department Civilian Attorney Referral List, and each has submitted an application. The Legal Assistance Department confirms the attorney's status as an active California attorney, and that he/she is not currently pending any formal disciplinary action by the California State Bar. The area of law in which a given attorney claims to practice has not been confirmed by Naval Legal Service Office Southwest. All clients are encouraged to utilize other avenues of assistance, such as the Yellow Pages, in finding qualified civilian legal assistance with which the client feels comfortable and confident.
