1. **Purpose.** To promulgate processing time goals for Navy activities involved in the processing of courts-martial.

2. **Cancellation.** OPNAVINST 5810.3, report control symbols JAG 5800-20 and JAG 5800-20A, and Report Forms NAVJAG 5800/43 and 5800/43A are cancelled upon compliance with the requirements of paragraph 5b.

3. **Discussion**

a. Experience has shown that effective management requires the establishment of management goals for processing Navy courts-martial for every segment of the court-martial process from initial knowledge of a suspected offense through final appellate review of a record of trial. Monitoring these goals will enhance the status of good order and discipline throughout the Navy and furnish the information required by various echelons of command to

promote efficiency, avoid unnecessary delay, effectively manage personnel assets, respond to requests for information from higher authority and facilitate tracking courts-martial throughout each segment of their processing.

b. The management goals delineated in enclosures (1) through (3) represent optimum averages to be obtained and are not mandatory standards. They create no individual rights or due process requirements and are independent of, and have no effect upon, the time standards which have been established by statutory or case law.

c. Different theaters of operation are faced with unique management concerns in the processing of courts-martial. Accordingly, CINCLANTFLT, CINCPACFLT, CINCUSNAVEUR and CNET are free to modify, without increasing the overall processing time goals, individual milestone goals for activities under their command in order to accomplish the objectives noted in paragraph 3a.

4. **Definitions**

a. **Knowledge of offense**—When the immediate commander first becomes aware that an identified member of his command is suspected of having committed a violation of any punitive article of the UCMJ. Where multiple charges and/or specifications are alleged against a member of his command, this is the date on which the immediate commander first became aware that that member was suspected of having committed any of the alleged offenses which become the subject of trial by court-martial. (See paragraph 4d).

b. **Charges preferred**—When charges are preferred in accordance with R.C.M. 307, MCM, 1984. Where multiple charges and/or specifications are alleged, this is the date of preferal of the latest charge which becomes the subject of trial by court-martial.

c. **Receipt by CA**—When preferred charges are received by the officer exercising summary court-martial jurisdiction. (See R.C.M. 403-405, MCM, 1984). Receipt by CA includes receipt by Convening Authority's staff judge advocate/legal officer. Where multiple charges and/or specifications are alleged, this is the date on which the latest charge preferred which becomes the subject of trial by court-martial

are received by the officer exercising summary court-martial jurisdiction.

d. If, at any time between knowledge of an offense and the sentencing or acquittal of an accused, the accused becomes an unauthorized absentee or is otherwise not under military control, count only the elapsed days when the accused was subject to military control.

5. Action

a. Management goals established in enclosures (1) through (3) apply to trials by summary court-martial, special court-martial and general court-martial convened in a Navy chain of command and initiated by the referral of charges on or after 1 August 1984.

b. Data for courts-martial in which the sentence was adjudged prior to 1 August 1984 will be reported in accordance with the provisions of OPNAVINST 5810.3. The JAG Management Information System (JAGMIS) currently under development will provide the capability to transfer and accumulate individual case data between and among all offices involved in processing courts-martial. This capability, when fully implemented, will eliminate the need for manually produced statistical reports. Therefore, recognizing the administrative burden that manual reporting requirements place upon operational commands,

no formal reporting requirements are imposed by this instruction.

c. The collection of court-martial management information during the interim period between the cancellation of the reporting requirements of OPNAVINST 5810.3 and full implementation of JAGMIS, both in terms of frequency of reports and information required, will be as directed by CINCLANTFLT, CINCPACFLT, CINCUSNAVEUR and CNET for activities under their command; by CNO (OP-09J) for GCM authorities not in the administrative chain of command of CINCLANTFLT, CINCPACFLT, CINCUSNAVEUR and CNET; and by the Judge Advocate General for the Office of the Judge Advocate General and the Navy-Marine Corps Appellate Review Activity. Enclosures (4) through (8) are samples of data collection worksheets to assist in compiling desired management information during this interim period.

d. Notify the CNO (OP-09J) of any modifications to individual milestone goals promulgated pursuant to paragraph 3c.
