1. Purpose. To promulgate enclosure (1).
2. Background. Reference (a) authorizes the Judge Advocate General (JAG) to prescribe rules governing the professional conduct and discipline of attorneys practicing under his supervision. Reference (b) promulgates such rules. Under reference (b), the JAG reviews investigations into professional misconduct and, if appropriate, imposes sanctions. These sanctions may include decertification under Articles 26 or 27 of the Uniform Code of Military Justice and suspension of authority to practice in any forum under the cognizance of the JAG.
3. Information. Enclosure (1) lists judge advocates (past and present) and civilian attorneys whose certification or authority to practice law in any area under the cognizance of the JAG is currently suspended, revoked, or limited. Such attorneys may not practice before courts-martial or the Navy-Marine Corps Court of Criminal Appeals. Their ability to practice before administrative discharge boards, courts and boards of inquiry, or as legal assistance attorneys may also be limited. The titles accompanying each name reflect only the status of each attorney at the time the JAG took action, and may no longer be accurate.
4. Action. Violations of the sanctions imposed on individuals listed in enclosure (1) shall be reported to OJAG (Code 13).
