

The following reports the results of every Special and General Court-Martial convened within the United States Navy in April 2019. The cases are separated by the Navy Region in which they were tried.

Naval District Washington

General Courts-Martial

- At a General Court-Martial in Washington, D.C., CTM3 Charles A. Crabb, USN, pled guilty pursuant to a pretrial agreement to two specifications of sexual abuse of a child. On 4 April 2019, the military judge sentenced him to a Dishonorable Discharge, reduction in rank to paygrade E-1, and confinement for 30 months. Pursuant to the pretrial agreement, all confinement greater than 364 days is to be suspended. The suspended confinement may be served if the Service Member violates the terms of the pretrial agreement.
- At a General Court-Martial in Washington, D.C., a midshipman was tried for sexual assault and obstruction of justice. On 12 April 2019, members returned a verdict of not guilty.
- At a General Court-Martial in Washington, D.C., IS2 Caleb E. Todd, USN, pled guilty pursuant to a pretrial agreement to indecent visual recording, larceny, possession and viewing of child pornography, and distribution of child pornography. On 30 April 2019, the military judge sentenced him to a Dishonorable Discharge, reduction in rank to paygrade E-1, and confinement for 7 years. Pursuant to the pretrial agreement, all confinement greater than 5 years is to be suspended. The suspended confinement may be served if the Service Member violates the terms of the pretrial agreement.

Navy Region Mid-Atlantic

General Courts-Martial

- At a General Court-Martial in Norfolk, Virginia, GSM3 Delonte M. Alexander, USN, pled guilty pursuant to a pretrial agreement to two specifications of providing a false official statement and wrongful use of a controlled substance. On 11 April 2019, the military judge sentenced him to reduction in rank to paygrade E-3 and confinement for 30 days. The pretrial agreement has no effect on the sentence. The pretrial agreement contained a waiver of the accused's administrative separation board.

- At a General Court-Martial in Norfolk, Virginia, ISC Ray D. Braimer, USN, was tried for sexual assault, two specifications of abusive sexual contact, sexual harassment, and attempted abusive sexual contact. On 18 April 2019, members returned a verdict of guilty of sexual assault, one specification of abusive sexual contact, sexual harassment and attempted abusive sexual contact and sentenced him to a Dishonorable Discharge, reduction in rank to paygrade E-1, and confinement for 2 years.
- At a General Court-Martial in Norfolk, Virginia, FCC Sean C. MacWhinnie, USN, was tried for viewing child pornography, possessing child pornography, and violating a lawful general regulation. On 26 April 2019, the military judge returned a verdict of guilty of viewing child pornography and violation of a lawful general regulation and sentenced him to a Dishonorable Discharge, reduction in rank to paygrade E-1, and confinement for 6 months.

Special Courts-Martial

- At a Special Court-Martial in Norfolk, Virginia, SA Hansel G. Ambunan, USN, was tried for aggravated assault. On 2 April 2019, members returned a verdict of guilty for the lesser included offense of simple assault and sentenced him to reduction in rank to paygrade E-1, a fine of \$1,500, and confinement for 30 days with an additional 60 days if the fine is unpaid.
- At a Special Court-Martial in Norfolk, Virginia, EODC Sean M. Conley, USN, pled guilty pursuant to a pretrial agreement to dereliction of duty, wrongful use of a controlled substance, and assault consummated by a battery. On 12 April 2019, the military judge sentenced him to reduction in rank to paygrade E-6 and confinement for 60 days. Pursuant to the pretrial agreement, all confinement greater than time served is to be suspended. The suspended punishment may be served if the Service Member violates the terms of the pretrial agreement. The pretrial agreement contained a waiver of the accused's administrative separation board
- At a Special Court-Martial in Norfolk, Virginia, BM1 Aaron J. Wilson, USN, was tried for five specifications of sexual harassment and six specifications of maltreatment of subordinates. On 23 April 2019, members returned a verdict of guilty to one specification of maltreatment of subordinates and sentenced him to no punishment.

Navy Region Southeast

General Courts-Martial

Special Courts-Martial

- At a Special Court-Martial in Jacksonville, Florida, AWOAN Darren T. Alexander Jr., USN, pled guilty pursuant to a plea agreement to unauthorized absence, wrongful use of a controlled substance, and larceny. On 5 April 2019, the military judge sentenced him to reduction in rank to paygrade E-2 and confinement for 105 days. The pretrial agreement had no effect on the sentence. The pretrial agreement contained a waiver of the accused's administrative separation board.

Navy Region Northwest

General Courts-Martial

- At a General Court-Martial in Bremerton, Washington, LCDR Jason S. Doyle, USN, pled guilty pursuant to a pretrial agreement to aggravated assault. On 2 April 2019, the military judge sentenced him to a Dismissal, confinement for 9 months, and a reprimand. The pretrial agreement had no effect on the sentence.
- At a General Court-Martial in Everett, Washington, an E5 was tried for four specifications of sexual assault. On 12 April 2019, members returned a verdict of not guilty.

Special Courts-Martial

- At a Special Court-Martial in Bremerton, Washington, EMN2 Alexander M. Bocculucci, USN, pled guilty pursuant to a pretrial agreement to two specifications of wrongful use of a controlled substance. On 4 April 2019, the military judge sentenced him to reduction in rank to paygrade E-1 and confinement for 2 months. The pretrial agreement had no effect on the sentence. The pretrial agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Bremerton, Washington, ABF3 Andre J. Freeman, USN, pled guilty pursuant to a pretrial agreement to assault consummated by battery and sexual harassment. On 15 April 2019, the military judge sentenced him to a Bad Conduct Discharge, reduction in rank to paygrade E-1, and confinement for 4 months. The pretrial agreement had no effect on the sentence.
- At a Special Court-Martial in Bremerton, Washington, AEAN Jacob C. Jones, USN, pled guilty pursuant to a pretrial agreement to five specifications of wrongful use of a controlled substance, two specifications of distributing a controlled substance, and two specifications of obstructing justice. On 16 April 2019, the military judge sentenced him to a Bad Conduct Discharge, reduction in rank to paygrade E-1, and confinement for 10 months. The pretrial agreement had no effect on the sentence.
- At a Special Court-Martial in Bremerton, Washington, EM2 Jiovanny A. Vargasvasquez, USN, pled guilty pursuant to a pretrial agreement to two specifications of sexual harassment, two specification of fraternization, and two specification of violating a

general order. On 17 April 2019, the military judge sentenced him to reduction in rank to paygrade E-3 and confinement for 150 days. Pursuant to the pretrial agreement, reduction in rank below the paygrade E-4 and confinement in excess of 90 days is to be suspended. The suspended punishment may be served if the Service Member violates the terms of the pretrial agreement. The pretrial agreement contained a waiver of the accused's administrative separation board.

- At a Special Court-Martial in Bremerton, Washington, FTSN Fernando Maldonado-Torres, USN, pled guilty pursuant to a pretrial agreement to wrongful use of a controlled substance. On 29 April 2019, the military judge sentenced him to reduction in rank to paygrade E-1 and confinement for 21 days. The pretrial agreement had no effect on the sentence. The pretrial agreement contained a waiver of the accused's administrative separation board.

Navy Region Southwest

General Courts-Martial

- At a General Court-Martial in San Diego, California, an E-4 was tried for three specifications of sexual assault. On 25 April 2019, members returned a verdict of not guilty.

Special Courts-Martial

- At a Special Court-Martial in San Diego, California, AA James E. Stogsdill, USN, pled guilty pursuant to a pretrial agreement to hazing, three specifications of battery, obstruction of justice, and drunk and disorderly conduct. On 3 April 2019, the military judge sentenced him to a Bad Conduct Discharge, reduction in rank to paygrade E-1, and confinement for 6 months. The pretrial agreement had no effect on the sentence.
- At a Special Court-Martial in San Diego, California, YN2 Cameron D. Kay, USN, pled guilty pursuant to a pretrial agreement to unauthorized absence and larceny. On 10 April 2019, the military judge sentenced him to a Bad Conduct Discharge, reduction in rank to paygrade E-1, and confinement for 100 days. The pretrial agreement had no effect on the sentence.
- At a Special Court-Martial in San Diego, California, AM2 Richard G. Langill, USN, pled guilty pursuant to a pretrial agreement to three specifications of assault consummated by battery. On 15 April 2019, the military judge sentenced him to a Bad Conduct Discharge and confinement for 11 months. Pursuant to the pretrial agreement, all confinement in excess of 8 months is to be suspended. The suspended confinement may be served if the Service Member violates the terms of the pretrial agreement.
- At a Special Court-Martial in San Diego, California, HN Marcus D. Webb, USN, pled guilty pursuant to a pretrial agreement to violating a lawful general order and 10

specifications of larceny. On 16 April 2019, the military judge sentenced him to a Bad Conduct Discharge, reduction in rank to paygrade E-1, and confinement for 12 months. The pretrial agreement had no effect on the sentence.

- At a Special Court-Martial in San Diego, California, MC3 Justin A. Schoenenberger, USN, pled guilty pursuant to a pretrial agreement to indecent recording. On 23 April 2019, the military judge sentenced him to a Bad Conduct Discharge, reduction in rank to paygrade E-1, and confinement for 7 months. Pursuant to the pretrial agreement, the Bad Conduct Discharge is to be disapproved and all confinement in excess of 4 months is to be suspended. The suspended confinement may be served if the Service Member violates the terms of the pretrial agreement. The pretrial agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in San Diego, California, EO2 Timothy J. Schultz, USN, pled guilty pursuant to a pretrial agreement to attempted sexual abuse of a child and five specifications of attempted receipt of child pornography. On 30 April 2019, the military judge sentenced him to a Bad Conduct Discharge, reduction in rank to paygrade E-1, and confinement for 12 months. Pursuant to the pretrial agreement, all confinement in excess of 9 months is to be disapproved. The pretrial agreement contained a waiver of the accused's administrative separation board.

Navy Region Hawaii

General Courts-Martial

Special Courts-Martial

- At a Special Court-Martial in Pearl Harbor, Hawaii, ENS Kenneth J. Janson, USN, pled guilty pursuant to a pretrial agreement to fraternization. On 23 April 2019, the military judge sentenced him to a reprimand and forfeiture of \$2,000 pay per month for 2 months. The pretrial agreement had no effect on the sentence.

Navy Region Japan

General Courts-Martial

Special Courts-Martial

- At a Special Court-Martial in Guam, GM3 Michael Y. Tajan, USN, pled guilty pursuant to a pretrial agreement to willfully disobeying a superior commissioned officer, indecent

recording, and indecent viewing. On 3 April 2019, the military judge sentenced him to reduction in rank to paygrade E-1 and confinement for 90 days. Pursuant to the pretrial agreement, all confinement in excess of time served is to be suspended. The suspended punishment may be served if the Service Member violates the terms of the pretrial agreement. The pretrial agreement contained a waiver of the accused's administrative separation board
